# Protecting LGBTQ+ People in NH

LGBTQ+ people are under attack by 30+ bills introduced this legislative session. We must protect these Granite Staters, who deserve to be treated fairly and equally in our state.

### Allowing Discrimination in Public Spaces<sup>1</sup>

New Hampshire state nondiscrimination law explicitly protects transgender people in employment, housing, public spaces (including restrooms), and public schools. **Transgender people are our friends, neighbors, family and co-workers. They work hard, attend school, serve in the military, and pay taxes.** When they walk into a school, library, or business open to the public, they should be treated like anyone else and not be discriminated against.

## Censorship in Schools<sup>2</sup>

Limiting a school's ability to have materials about or referencing gender identity or sexual orientation **violates a basic trust that all students, including LGBTQ+ students, can learn and thrive in a safe environment.** It controls what students can and cannot read, what they can and cannot learn, and — most troublingly — who they can and cannot be.

### Bans on Participation in Sports for Transgender Youth<sup>3</sup>

Sports and athletics are an important part of childhood, offering opportunities to build a sense of belonging and learn important life skills like teamwork, leadership, confidence, and selfdiscipline. No child should be denied the opportunity to participate in sports simply because of their gender identity. The overwhelming majority of transgender youth, like most kids, don't play at elite levels; they just want to participate with their peers.

#### **Current Legislation:**

HB 396 & SB 562: gives any public or private person or organization the ability to discriminate against LGBTQ+ people by designating which restrooms, locker rooms or sports teams they can use or participate on.

- HB 396: Passed House, 192–184; In Senate Committee
- SB 562: Defeated in Senate

#### **Current Legislation:**

- SB 341 requires teachers to "out" students to their parents when requested (passed Senate, 13-10; House vote May 2).
- SB 523 requires school boards to create policies for banning books and materials, granting principals the power to unilaterally ban such materials (Defeated).

#### **Current Legislation:**

- HB 1205: Bans transgender girls from playing school sports (passed House, 189-182; in Senate Committee).
- **SB 375:** Bans transgender girls from playing school sports in school and college (passed Senate, 14-10; **House vote May 2**).
- **SB 524:** Bans transgender girls from playing sports in school and college (Interim Study).

## Bans on Medically Necessary Care for Transgender Youth <sup>4</sup>

Transgender youth, like all youth, have the best chance to thrive when they can get the doctorprescribed medical care they need when they need it. Gender-affirming care is evidence-based and supported by medical authorities like the American Academy of Pediatrics and the American Medical Association. **Medical decisions should rest solely with doctors, parents, and the patient - not politicians**.

#### **Current Legislation:**

- **HB 619:** Bans surgery for transgender youth (passed House, 188-175; in Senate Committee).
- **HB 1011:** Criminalizes medically necessary care for transgender youth (Defeated in House).
- **HB 1660:** Bans Medicaid insurance plans from covering gender-affirming surgeries (passed House, 193-169; in Committee).

# THE HARM OF DISCRIMINATORY LEGISLATION

Legislation and discrimination negatively impact the health and well-being of LGBTQ+ youth. LGBTQ+ people often experience anxiety, depression, and thoughts of suicide - these are NOT inextricably linked to their sexuality or gender identity but rather occur due to stigma, discrimination, and lack of access to affirming spaces and health care.<sup>5,6</sup> Alternatively, when LGBTQ+ youth feel support, acceptance, and open representation within their homes, schools and communities, they have much better mental health, educational and social outcomes.<sup>6</sup>



## **THE BOTTOM LINE**

Legislation that discriminates against LGBTQ+ Granite Staters has no place in New Hampshire. We need to build an inclusive New Hampshire - one where our children can navigate their daily lives as kids, participating in sports, using restrooms, reading books, and NOT experiencing discrimination due to their gender identity or sexual orientation. We must protect LGBTQ+ people in our state.
