## **Rising Prescription Costs in New Hampshire**

Across New Hampshire, rising prescription prices are driving up out-of-pocket costs, leaving many individuals, families, and older adults unable to afford the medications they need. A recent survey found that Granite Staters are struggling to afford their prescriptions across all income levels.




worried about affording their prescriptions<sup>1</sup>

## SB 647: A No-Cost, Privacy-First **Prescription Discount Card Program**

SB 647 would bring a free, privacy-first prescription discount card program to New Hampshire. The program would save Granite Staters money on their prescriptions and offer nationwide pharmacy access—all without selling their personal data.

By helping New Hampshire address rising prescription costs while putting the savings directly into the pockets of Granite Staters, this program benefits everyone.



## **Key Features of the Program**



**Significant Savings for Patients** Substantial discounts on both generic and brand-name medications, with some saving an average of \$219/month.2



No Cost to Patients or the State Free for residents to use with no membership fees, enrollment costs, or taxpayer funding required.



#### **Privacy Protection**

Unlike commercial discount cards, patient data is not sold to third parties or used for commercial purposes.



#### **Universal Access**

Available to all NH residents regardless of insurance status or income level.



#### **Revenue Generation**

Can generate revenue for NH that can be reinvested into other health care priorities.










## **How Do Prescription Discount Cards Work?**

Prescription discount card programs offer a way for anyone to save on medications. You can use a discount card instead of insurance or Medicare when your plan doesn't cover a medication, or when the discount card provides a better price than what you'd pay through your insurance or Medicare.

### **How Much Could You Save?**

Savings vary, but for one discount card program, the average savings is 80% for generic drugs and 18% for brand drugs. For a generic blood pressure medication (Lisinopril), the retail price is about \$56, and the discount card could bring the price to as low as \$8, saving you \$48 on a 30-day supply.2
